

THE SPEED OF THE DISMISSAL PROCESS:

75% of clients saw an increase in the speed of dismissal. Dismissal is down to 15 minutes to dismiss 235 kids.

One client stated: *"More efficient and cut down dismissal time by more than 10 minutes."*



CHILDREN'S SAFETY CONDITIONS DURING DISMISSAL TIME ARE:

78% of clients saw some improvement. 47% of clients saw significant improvement.

One Client Stated:

"Now we have a way to track students being dismissed. We mark them that they got on the bus or have been picked up as a car rider; it's a lot safer."











COSTS ASSOCIATED WITH THE DISMISSAL **PROCESS HAVE BEEN:**

28.57% of clients surveyed said that costs had either Ostayed the same or increased since implementing PikMyKid. 65% of clients surveyed said that costs had increased. One client explained that the app itself costs money, and has not saved any money.






TRAFFIC CONGESTION ON AND AROUND SCHOOL CAMPUS IS:

HOW WOULD YOU DESCRIBE THE IMPLEMENTATION PROCESS OF PIKMYKID AT YOUR CAMPUS:




